made more than **\$1,000,000 in capital improvements**



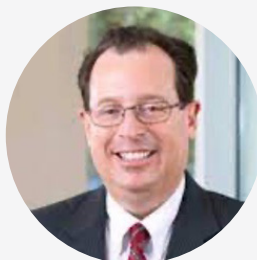
distributed a **payroll of approximately \$33 million** to our 470 employees

In 2024, we made significant strides as a hospital committed to providing high-quality care, close to home. We were named a "Best Ohio Workplace"

and a "Best Ohio Business" by Ohio Business Journal, we were designated a Surgical Quality Partner by the American College of Surgeons, and we were honored for our stroke care by the American Heart Association and organ donor promotion by Network for Hope.

We also prioritized the enhancement of our orthopedic service line through a strategic partnership with Beacon Orthopaedics. This collaboration has ensured 24/7 Emergency Department coverage for orthopedic injuries, expanded access to highly specialized orthopedic care, and elevated the level of musculoskeletal care available in our community.

## 2024 Success Spotlight

Recruiting skilled clinicians to our hospital and community and supporting them in their new roles is critical to ensuring access to high-quality care across a broad spectrum of services. In 2024, we added 36 providers in areas that included Anesthesiology, Diagnostic Radiology, Emergency Medicine, Hospital In-Patient Care, Orthopedic Surgery, Pain Management, Psychiatry, and Radiation Oncology.

Investments in our facilities – from infrastructure to the latest healthcare technology – ensure that our hospital can continue to meet the community's evolving healthcare needs. Last year, we spent more than \$1 million on capital improvements, including the addition of an orthopedic fracture table, a low-temperature sterilizer, a new nurse call system, a new ultrasound, a new air chiller, and a new generator for our cancer center.

Our greatest asset is our people, so we aspire to create an environment where talent is recognized, job satisfaction is valued, and our employees can effectively use their skills to provide high-quality care and service.

In 2024, we provided nearly \$10 million in services to those in need of healthcare but without the means to pay.

We are proud to be a leader in the Wilmington area and our partnership with the local community is manifest in many ways, from being a large taxpayer and employer to being a supporter of several local organizations.
